RrSG Observer Pilot Program

WHAT IS AN RrSG OBSERVER?

 A non-member ICANN-accredited registrar who can participate in closed RrSG meetings and communications of the RrSG in a limited capacity and for a limited period of time to see how it operates and the benefits of being involved.

WHO IS ELIGIBLE?

- Any ICANN-accredited registrar that is not a current member, has not been a member in the last 5 years, and has not been an observer before.
 - Resellers are not considered eligible at this time.
- Participation numbers may be capped at the discretion of the RrSG ExCom (e.g., if a high number of applications are received).
- A RrSG Observer application form must first be completed (with the same information required for new member applications including affiliations, conflict of interest, etc.), which will be reviewed and confirmed for acceptance by the ExCom.

HOW LONG CAN A REGISTRAR BE AN OBSERVER?

• Observer Status will run for 6 consecutive months starting on 1st of the month after approval of the application.

WHAT BENEFITS WILL OBSERVERS GET?

OBSERVER TERMS

- Participation on the RrSG Member mailing list should usually be limited to read only, but Observers are permitted to email the mailing list to ask registrar-related questions.
- Participation in RrSG Membership meetings should be limited to listening only (no comment in the chat) but time will be allocated at the end of every meeting for Observers to ask questions.
- Participation in the one chosen RrSG subgroup should be limited to listening only but comment in chat is permitted.

IS THERE A FEE TO BE AN RrSG OBSERVER?

- There will not be any fee to be a RrSG Observer.
- If a RrSG Observer decides to become a full member (whether before or at the end of the program) they will need to pay the usual membership fee to join (which may be pro-rated).

WHEN WILL THE RrSG OBSERVER PROGRAM START?

- The RrSG Observer Program will start initially as a one year pilot in 2025, at the end
 of which the success of the program will be considered to determine if it should
 continue as a permanent part of the RrSG.
- The RrSG Observer Pilot Program will start shortly after membership has given their final approval.
